Artemis Attendance Policy

Overview

The Artemis Project runs from Monday, **June 29** to Friday, **July 31** from **9:30am** to **3:00pm**, with no camp on Friday, July 3, for Independence Day.

Policy

We hope to have a great summer filled with fun and exciting activities and opportunities for all of the girls! Therefore, regular attendance and punctuality are essential for the smooth operation of the Artemis Program. **Daily attendance is required and expected.**

- 1. **Absence**: An absence is defined as the failure of any student to report to Artemis when camp is in session. In order for an absence to be excused, prior notification through email or a phone call is required. The exception to this is any emergency situation. In the case of an emergency, please contact us at your earliest convenience. Three unexcused absences warrant a dismissal from Artemis.
- 2. **Tardy**: Tardiness occurs when a student is not present, and ready to begin working, at camp's scheduled start time. Tardiness also occurs when a student leaves Artemis prior to the end of Artemis' scheduled end time without prior approval. Three tardies is equivalent to one absence.
- 3. **No Call/No Show**: Students must report an expected tardy or absence outside of emergency circumstances. This allows the coordinators to properly keep track of a student's location throughout the duration of the camp.

What are Excused Absences?

- 1. Personal illness.
- 2. Quarantine under the direction of a health officer.
- 3. Personal medical, dental, optometric or chiropractic appointment.
- 4. Funeral services for a member of the immediate family.
- 5. Family emergencies.
- 6. Personal court appearance.
- 7. Observance of a religious holiday or ceremony.
- 8. Spending time with an immediate family member who is an active duty member of the military.
- 9. A bus arriving later than the specified time or breaking down during commute.
- 10. Other reasons that are within the discretion of Artemis Coordinators and, based on the factors of the student's circumstances, are deemed to constitute a valid excuse.

Code of Conduct

1. Mission

The mission of the Artemis Project is to provide a safe, supportive, and resourceful environment for rising ninth grade girls from the community around Brown University in which they can cultivate their interests in Computer Science for five weeks during the summer. The founders designated Artemis as a women-only program to provide the following:



a. Female role models and mentors in Computer Science.

b. A supportive environment in which the participants can exercise their skills and creativity.

c. A context in which the participants are exposed to the field of Computer Science without the interference of societal discrimination and/or prejudices based on gender.

2. Offenses and Penalties

Listed below are offenses which may warrant suspension from the Artemis Project, dismissal from the Artemis Project, and/or notification of your parents or guardians:

a. Behavior which disrupts or materially interferes with the Artemis program

b. Behavior which:

1. Causes or can be reasonably expected to cause physical harm to a person

2. Shows flagrant disrespect for the well-being of others

3. Is unreasonably disruptive of the Artemis Project, the University community, and/or the areas that we visit on a field trip

4. Causes or can be reasonably be expected to cause damage to property

c. Behavior that can be classified as sexual misconduct

d. Harassment: The subjection of another person or group to abusive, threatening, or intimidating actions, including but not limited to those based on race, religion, gender, handicap, ethnicity, national origin, or sexual orientation.

e. Possession or use of drugs and/or alcohol and/or drug paraphernalia except for drugs of medicinal purposes of which I will fully notify the coordinators of the Artemis Project.

f. Use of tobacco during the hours and activities of the Artemis Project

g. Theft:

1. Theft or attempted theft of personal or University property

- 2. Possession of stolen personal or University property
- h. Weapons:

1. Possession, use, or distribution of firearms, ammunition, explosives, or arms of any nature, especially those which are capable of causing harm to persons or damage to property.

2. Possession of weapons of any other kind.

i. Tampering with fire safety equipment or causing a fire alarm to be sounded by negligence or vandalism.

Adventure based activities are exciting, challenging, and both physically and mentally demanding. Some activities may be stressful and possibly hazardous. 
